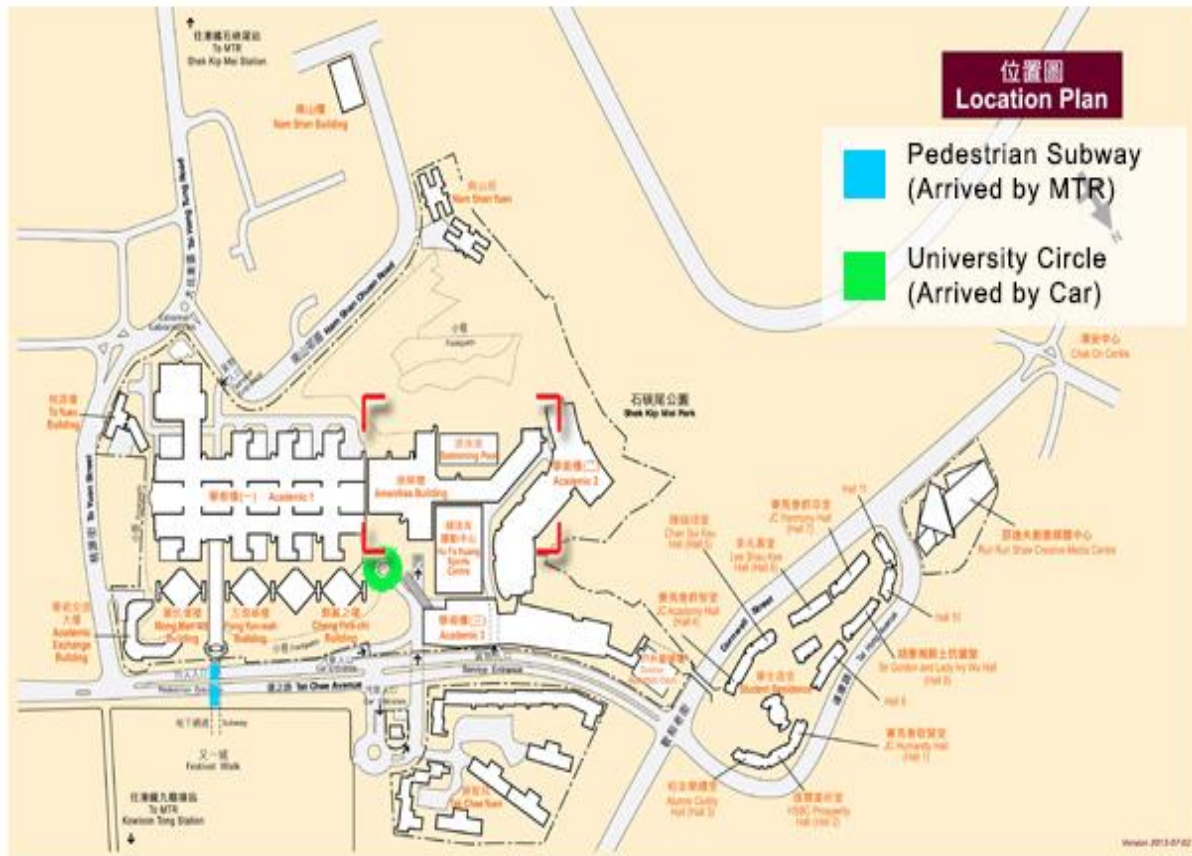

鍾先生對大廈管理的法律甚有研究。曾於 1988 年至 1991 年獲政府委為〈私人大廈管理諮詢委員會〉主席，負責修訂該條例，並改名為《建築物管理條例 (344 章)》。

鍾先生現分別為政府委任的〈規管物業管理行業諮詢委員會〉及〈建築物管理條例檢討委員會〉的主席。

鍾先生於 1988 年獲委太平紳士，1991 年獲大英帝國官佐勳章，2005 年獲香港特別行政區政府頒授銀紫荊星章，及 2012 年獲頒金紫荊星章。

### **Profile of Ms. Diana Pang**

Diana Pang joined the Competition Commission as Senior Manager (Operations) in June 2014. Prior to her present role, she was a Chief Investigator with the Operations Department, Independent Commission Against Corruption. Diana is a Certified Fraud Examiner and a Registered Social Worker in Hong Kong.

Diana has vast experience in criminal investigation and criminal proceedings in various Courts in Hong Kong. She also has secondment experience in working with the Metropolitan Police Service, London, UK (2007-2008) and the Competition Bureau, Canada (2015).

Diana graduated with a B.Bs in Social Work from the Chinese University of Hong Kong and was an exchange student at the University of California, Los Angeles. She also has an LLB from the University of London and Postgraduate Diploma in EU Competition Law from King's College London.
